FitNation

Alcohol: No alcoholic beverages shall be sold, brought within, given away, delivered or consumed on Park District property. Evidence of any alcohol consumption will result in the immediate termination of the rental and loss of Renter's security deposit.

Attendance: To ensure the safety of your guests, the total number of your party may not exceed max attendance listed on the approved application. *If the actual attendance is larger than the number stated on this application, the deposit may be forfeited.*

Behavior: All activities must be conducted in an orderly manner. Foul or abusive language, attempted/physical confrontation is not permitted and will result in immediate expulsion from the facility. Running, horseplay, rough housing, sitting on shoulders, piggybacking, spitting water, etc. is not allowed.

Attire: Health Department regulations stipulate proper bathing suit attire is required and must be worn at all times. No underwear, street clothes, cutoffs, basketball shorts, shoes or diapers are allowed. Children who are not toilet trained must wear swim diapers and a tight fitting rubber or plastic swim pant over the diaper. T-shirts may not be worn while swimming except for medical reasons. Aqua-Shirts are allowed.

Cancellations: Must be in writing from the renter listed on the application 30 days prior to the rental date in order to receive a refund of all rental fees less a \$15.00 service charge. After that time, no refunds are issued for cancellations including all rental fees paid.

Clean Up: Gurnee Park District property and equipment must be restored to its original condition and all decorations must be removed by the renter following the event. Insufficient clean-up will affect the refund of the renter's deposit.

Decorations: Decorations may be affixed using painters tape or string in the viewing area. No staples, tacks, screws, nails or other types of clear tape are permitted. Confetti, glitter, and sprinkles are prohibited.

Deposit Refunds: The Security Deposit is due at the time of registration and is not included in the rental fees. After the event, an inspection of the premises will be completed. The deposit will be refunded in full if the renter complies with all the rules and regulations on the approved rental application. It is further agreed to reimburse the Park District in full for any costs for repair, replacement or cleaning of the premises or equipment which exceed the amount of the deposit. All refunds are processed in the form of a check or credit card. Upon approvals, refunds will be issued 7-10 days following the rental. Checks will not be available for pickup.

Emergency Contact: On the day of your event, call the FitNation Pool office at 847-623-4525.

Entrance: Please arrive at 6:45p and check in with the front desk. Your party will be let in through the side entrance near the fence at 7:00p. Signage will be posted for your guests as the building will be closed.

Guests: *All swimmers must shower before entering the pool. For children under 8 years old, there must be 1 adult in the water within arm's reach for every 8 children in the water. For children 9 years old and older, there must be 1 adult in the water within arm's reach for every 10 children in the water*

Hot Tub: Strictly for patrons 18 years of age and older.

Hours: All events must start and end per hours listed on the approved rental application to avoid an additional charge of \$50 per 30 minutes.

Family Locker Room: Renters must utilize the Family Locker Room furnished with 6 showers, 2 changing rooms and 4 restrooms. Lockers may be used; please bring a lock from home if desired. All participants are encouraged to take a shower before entering the pool. Private showers or restrooms must be used during changing; **please provide your own toiletries and towels.** Any cell phone of any type or kind regardless of its capacity or lack thereof to produce a visual image (since a cell phone's capability to produce images is not readily apparent to the casual observer) is prohibited to use in any area of the locker rooms. Gurnee Park District / FitNation is not responsible for lost, stolen or damaged personal items or personally rented equipment. **General Locker Rooms will not be available during the rental.**

Rules & Regulations

Lifeguards: Our Ellis & Associates trained Lifeguards are there for your safety, to enforce rules and respond to emergencies. Please follow their instructions along with the pool rules posted throughout the facility at all times.

Lifejackets: U.S. Coast Guard approved lifejackets are available for use, free of charge. For children using lifejackets, 1 adult to 1 child ratio must be met.

No Smoking: Gurnee Park District Ordinance prohibits use of any tobacco products on or within twenty-five feet of any Gurnee Park District playground, sports field, skate park, shelter or structure. Please use designated smoking areas.

Personal Flotation Devices / Water Toys: Inflatable personal flotation devices, masks, fins, snorkels, squirt guns, plastic toys, diving sticks, water wings, and beach balls are welcome!

Payment: MasterCard, VISA, Discover, cash and checks accepted. All fees are to be paid in full 30 days prior to your scheduled event. A \$25 service charge will be assessed on all NSF checks.

Rescheduling: Dates are subject to availability and an administrative fee of \$15.00

Resident Rate: The term "resident" refers to Park District residents who live within Gurnee Park District boundaries and who contribute financial support to the Park District through taxes. Some residents with a Gurnee mailing address may not be residents of Gurnee Park District. Proof of residency is required with the application including a valid Driver's License or State ID.

Renter: Renter must be 21 years of age or older and in attendance during the entire event. The renter must declare on the application all activities which will take place on Park District property. The Renter will assume full responsibility for the rental and liability and is solely responsible for the actions of any member of the group. ***The Renter and guests are limited to using only the requested and approved areas on the application. Use of additional rooms/outlying spaces are strictly prohibited.***

Tickets/Fees: The Renter may not charge an admission, sell tickets or solicit donations on park district property without the written consent of Gurnee Park District Director and Board of Commissioners. This includes selling any articles or accepting orders for articles. Gambling in any form is prohibited.

Viewing Area: The Viewing Area will be set up with tables and chairs for up to 25 guests with an additional table for your refreshments or gifts.

By signing below, I confirm that I have read, fully understand and will comply with all facility rules/guidelines. Renter understands and agrees that it is renter's sole responsibility to provide supervision for any and all activities contemplated by this agreement. Renter further understands and acknowledges that lifeguards are not responsible for providing supervision; rather, lifeguards are responsible for enforcing safety rules and responding to emergencies. Further, Renter and Renter's guests are solely responsible for any aquatic activity contemplated by this agreement and that Gurnee Park District / FitNation is not responsible for assessing the skills of any patron. Additionally, Renter understands and agrees that children 12 years of age and younger must be supervised at all times by a responsible person, 16 years of age or older and it is renter's responsibility to enforce this requirement. Accordingly, renter agrees that he/she shall communicate this requirement to all guests/patrons associated with and attending this event. Renter agrees to protect, indemnify, save and hold harmless Gurnee Park District / FitNation including its officers, officials, employees, agents and volunteers (collectively "District") from and against any and all liabilities, obligations, claims, damages, causes of action, costs and expenses, (including reasonable attorney fees) which Gurnee Park District / FitNation may become obligated by reason of any accident, injury, or drowning of any member of Renter's group (or caused by a member of Renter's group) arising indirectly or directly in connection with or under this agreement.
