SWIM SCHOOL AT FITNATION AGREEMENT

- 1. **MONTHLY DUES:** Monthly dues will be collected on the 2nd of each month for the current month. Rejected monthly EFT charged on credit cards and checking accounts are subject to a \$10.00 service charge.
- 3. **CLASSES:** Management reserves the right to change hours or combine classes to best use the resources of the program. Examples of the necessity to change hours of operation may include but not be limited to member usage, repairs, special events, acts of nature, and yearly maintenance.
- 4. **RATE CHANGE:** Monthly rates and enrollment fees on either side of this agreement and all policies are subject to change unless protected for set periods of time, indicated within this agreement. In the event that automated debits have been previously agreed to, Gurnee Park District will assume the member's acceptance of any rate change unless Gurnee Park District is notified in writing.
- 5. **MAKE-UPS:** All members are allowed 12 makeups a year. If you need to miss class and are seeking a make-up option, submit a makeup request <u>prior</u> to the missed class by submitting a makeup request submission form on the Gurnee Park District website. Make-ups for make-ups are not offered and cannot be extended beyond your enrollment.
- 6. **TEMPORARY SWIM SCHOOL HOLD:** Students may place a temporary hold on their pass for a maximum of four months under the following conditions: temporary job relocation, illness or seasonal change of residence. Proof of circumstances will be required consisting of a letter from the member's company stating the relocation, a note from a doctor stating that the member is unable to swim due to illness/injury and/or proof of residency outside the state of Illinois. This policy will not be offered retroactively; an official hold form must be completed prior to the beginning of the month for which the first hold month is to occur and a \$5.00 maintenance fee for each month will be requested. A membership may only be placed on hold one time within a 12-month period.
- 7. **CANCELLATIONS:** All cancellation forms must be completed by the 15th day of the current month to be processed for the following month. Any cancellation submitted after the 15th day of the month will be charged for the upcoming month and cancelled thereafter. A minimum 30 day notice is required. A \$5 cancellation fee is applied upon cancellation
- 8. **COMPLIANCE WITH RULES:** It is expected that all members be in compliance with the rules of Gurnee Park District. Management reserves the right to add or delete rules for the Aquatic Facility as required. Management also reserves the right to exercise discretion when considering the conduct required insuring a pleasant, safe, harmonious environment for the members, staff and guests of Gurnee Park District. Violation of the rules of Gurnee Park District could result in the suspension or cancellation of membership.

WAIVER AND RELEASE OF ALL CLAIMS AND ASSUMPTION OF RISK

Please read this form carefully and be aware that, in signing up and participating in Gurnee Park District programs, you will be waiving and releasing all claims for injuries, arising out of these programs, that you or the other named participants might sustain. The terms I, me, and my also refer to parents or guardians as well as participants in the programs. In registering for these programs you are agreeing as follows: As a participant in these programs, I recognize and acknowledge that there are certain risks of physical injury and I agree to assume the full risk of any injuries, damages or loss which I may sustain as a result of participating in any manner, in any and all activities connected with or associated with such programs. I further recognize and acknowledge that all athletic activities involving strenuous exertion or potential body contact are hazardous recreational activities and involve substantial risks of injury. I agree to waive and relinquish any and all claims I may have as a result of participating in these programs against the Gurnee Park District, any and all other participating or cooperating governmental units, any and all independent contractors, officers, agents, servants and employees of the governmental bodies and independent contractors, and any and all other persons and entities, of whatever nature, that might be directly or indirectly liable for any injuries that I might sustain while participating in these programs. (The parties described in the preceding sentence are referred to as released parties in the remainder of this Agreement). I do hereby fully release and discharge the Gurnee Park District and the other released parties from any and all claims for injuries, damage or loss which I may have or which may accrue to me on account of my participation in these programs. I further agree to indemnify, hold harmless and defend the Gurnee Park District and any and all other released parties, from any and all claims resulting from injuries, damages and losses sustained by anyone, and arising out of, connected with, or in any way associated with my conduct and the activities of these programs. I further understand and agree that the terms such as participation, programs, and activities, referred to in this Agreement, include all exercises and physical movement of any nature while I am participating in these programs and further include the provision of or failure to provide proper instructions or supervision, the use and adjustment of any and all machinery, equipment, and apparatus, and anything related to my use of the services, facilities, or premises involved in these programs, and transportation to and from any events. I understand the nature of these programs for which I am registering and have read and fully understand this Waiver, Release and Hold Harmless Agreement. I further understand that any advisements or warnings of the particular risks of these programs that I subsequently receive will be incorporated by reference into and become a part of this agreement.
