Attire: Health Department regulations stipulate proper bathing suit attire is required and must be worn at all times while in the water. No underwear, street clothes, cutoffs, basketball shorts, shoes or diapers are allowed. Children who are not toilet trained **must** wear swim diapers and a tight fitting rubber or plastic swim pant over the diaper. *Both Swim Diapers and Swim Pants are available for purchase at the Ticket Office for your convenience.* T-shirts may not be worn while swimming except for medical reasons. Aqua-Shirts are allowed.

Cancellations: Must be in writing from the renter listed on the application 48 hours prior to the rental date in order to receive a refund of all rental fees less a \$50.00 service charge. After that time, no refunds are issued for cancellations including all rental fees paid. **Refunds are not issued if the actual attendance is less than the paid attendance.**

All refunds are processed in the form in which you paid. Cash will be paid in the form of a check. Upon approvals, refunds will be mailed 7-10 days following the rental.

Check-in: Renter should check in at the ticket office 15 minutes prior to their rental time to turn in their attendance sheets and menu request.

Closure: The Aquatic Center may be closed if the temperature is below 70 degrees, moderate to heavy rainfall, thunder, visible lightning or ThorGuard system is in alarm. In case of inclement weather where cancellation is made by the Aquatic Center staff, the Pool Manager will make every effort to notify you. Decision to open the pool is made at 9:45a daily. To reach the Aquatic Center directly the day of your event, please call **847-599-3780** if you are unsure on the opening status, you can also use the Park District Rainout Line app for up to date information. If we close due to weather within an hour of your arrival, we will be happy to reschedule your event within the same season. No refunds will be issued if the party experiences inclement weather after the first hour of the visit.

Decorations: Any additional decorations may be affixed using painters tape, string, or Command hooks ONLY. Confetti, glitter, and sprinkles are prohibited. Helium balloons must be anchored down. Gurnee Park District property and equipment must be restored to its original condition and all decorations must be removed by the renter following the event.

Guests: All swimmers must shower before entering the pool. For children under 8 years old, there must be 1 adult (18+) in the water within arm's reach for every 8 children in the water. For children 9 years old and older, there must be 1 adult (18+) in the water within arm's reach for every 10 children in the water. **All persons entering the front gate will be counted as party participants; including non-swimming adults.**

Hours: Regular weekday pool hours are from 12-7p, weekend hours are from 11a-7p.

Lifeguards: Our Ellis & Associates trained Lifeguards are there for your safety, to enforce rules and respond to aquatic emergencies. Please follow their instructions along with the pool rules posted within the facility at all times.

Party Package: Fees listed are for parties of 17 children and 3 adult chaperones for a safe ratio. Party package is limited to 40 guests. **A final guest count is due 3 days prior to your visit.**

Party Area: Your tented party area including 9 picnic tables and one gift table, is available for your 3 hour reserved party time. Upon conclusion of the party, guests are welcome to stay and enjoy the Aquatic Center, but must clear the party area promptly.

Payment: Party package fees are to be paid in full upon registration. Payment for additional guests or food will be due the day of your party. A \$25 service charge will be assessed on all NSF checks. MasterCard, VISA, Discover, cash and checks accepted.

Refreshments: Meals include a small drink, one side and your choice of a hot dog or a slice of pizza for 20 attendees. Meals will be served at 12:45p or 4:45p based on your reservation time regardless if all of your guests have arrived. Additional food may be purchased at our Cattail Café. Outside food is allowed. Refrigerator & freezer space is available to hold your birthday cake until ready to serve. Food must be kept in the party area, grassy picnic area or on the concession deck only.

General Rules and Birthday Party Guidelines

Renter: Renter must be 21 years of age or older and in attendance during the entire event. The renter will assume full responsibility for the rental and liability and is solely responsible for the actions of any member of the group both in and out of the water.

Resident Rate: The term "resident" refers to Park District residents who live within the Gurnee Park District boundaries and who contribute financial support to the Park District through taxes. Some residents with a Gurnee mailing address may not be residents of the Gurnee Park District. Proof of residency is required with the application including a valid Driver's License or State ID.

Safety Breaks: If the outside temperature is above 75 degrees; safety breaks will be taken 3 times daily.

Further, Renter and Renter's guests are solely responsible for any aquatic activity contemplated by this agreement and that the Gurnee Park District is not responsible for assessing the skills of any patron. Additionally, Renter understands and agrees that children 12 years of age and younger must be supervised at all times by a responsible person, 16 years of age or older and it is renter's responsibility to enforce this requirement. Accordingly, renter agrees that he/she shall communicate this requirement to all guests/patrons associated with and attending this event. Renter agrees to protect, indemnify, save and hold harmless the Gurnee Park District including its officers, officials, employees, agents and volunteers (collectively "District") from and against any and all liabilities, obligations, claims, damages, causes of action, costs and expenses, (including reasonable attorney fees) which the Gurnee Park District may become obligated by reason of any accident, injury, or drowning of any member of Renter's group (or caused by a member of Renter's group) arising indirectly or directly in connection with or under this agreement.

The Gurnee Park District is not responsible for lost, stolen or damaged personal items or personally rented equipment.
