This service allows you to schedule a fun-raiser night at Gurnee Park District's Hunt Club Park Aquatic Center. Fun-raiser night requests are not deemed approved unless submitting organization (if acceptable, "organization") receives a confirmation email from Gurnee Park District accepting the request. If Fun-raiser night is approved, the date and time approved (the "fundraising night") will be referenced in the approval email and the following terms and conditions apply:

All scheduled fun-raiser nights are subject to cancellation by Gurnee Park District at their discretion. You will be provided with one electronic version of the event fundraising flyer (the "Flyer") for copying and distribution by the organization as described below. The flyer artwork, excluding the organization name and logo, is the property and owned by Gurnee Park District and may be used by organization only as described in these terms and conditions; Gurnee Park District will donate to the organization \$3 of every paid admission during the fun-raiser night for sales where a flyer is presented (digitally or physically – smart phones are acceptable) or organization mentioned at the time of purchase as hereinafter described.

Gurnee Park District will mail a check to organization for the total donation amount approximately 30 days following event. In connection with the fun-raiser night, the organization may use the name and logo of Gurnee Park District, as applicable, only to promote and otherwise factually describe the fun-raiser night provided; however, the organization may issue a press release to local media promoting the fun-raiser night, with written approval from Gurnee Park District. For approval, please contact kmoss@gurneeparkdistrict.com. The organization will make copies of the flyer at its own expense. All other advertising costs related to the fun-raiser night incurred by the organization are also the responsibility of the organization. The organization has the right, but not the obligation to: At its own expense, send flyers to all supporters in the organization's database, post to organization's website, social media pages, and distribute to the organization's employees, friends, families and members of the community to promote the Fun-raiser night. The organization MAY NOT hand out flyers at the entrance of the Aquatic Center at any time, it must promote the fun-raiser night in its own space and at its own fun-raiser nights.

Fun-raiser applications must be filled out in full with the waiver signed and dated in order to process your application. Reservations may be placed in person at either Community Center, via email or fax. No reservations will be taken via phone or on-line. Reservations are approved on a first-come, first-served basis, as measured by the receipt of a complete application. Submitting an application is not a confirmation of the fun-raiser. Gurnee Park District reserves the right to reassign space without notice. Park District programs have priority in scheduling. Fees are subject to change.

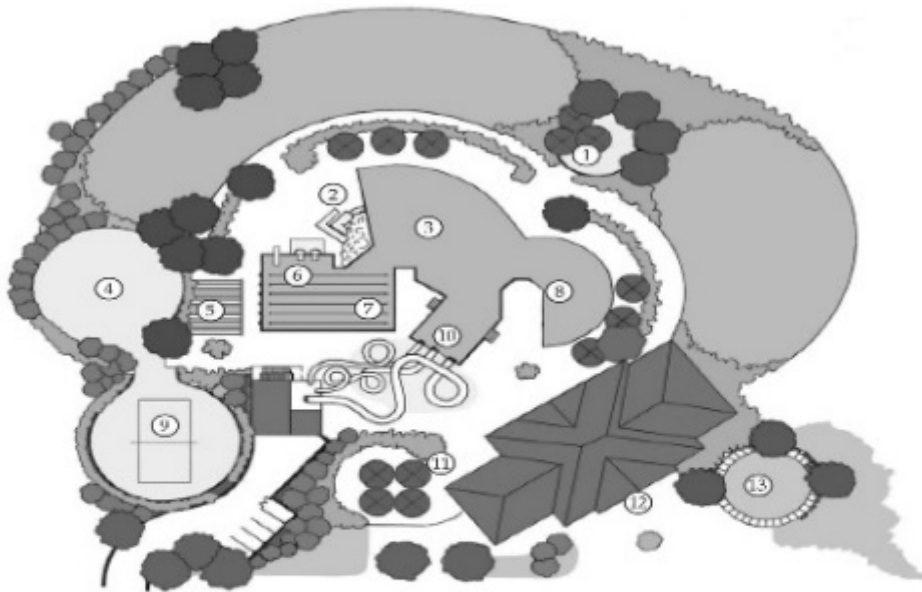

Alcohol: No alcoholic beverages shall be sold, brought within, given away, delivered or consumed on Park District property.

Arrival: The Organization should check in and turn in their attendance sheets and permit at the ticket office.

Attire: Health Department regulations stipulate proper bathing suit attire is required and must be worn at all times. No underwear, street clothes, cutoffs, basketball shorts, shoes or diapers are allowed in the pool. Children who are not toilet trained must wear swim diapers and a tight fitting rubber or plastic swim pant over the diaper. Both swim diapers and swim pants are available for purchase at the Ticket Office for your convenience. T-shirts may not be worn while swimming except for medical reasons. Aqua-shirts are allowed but prohibited on all slides.

Behavior: All activities must be conducted in an orderly manner. Foul or abusive language, attempted/physical confrontation is not permitted and will result in immediate expulsion from the facility.

Closure: The Aquatic Center may be closed if the temperature is below 70 degrees, moderate to heavy rainfall, visible thunder, lightning or ThorGuard system is in alarm. In case of inclement weather where cancellation is made by the Aquatic Center staff, the Pool Manager will make every effort to notify you. The decision to open the pool is made at 9:45 am daily. **To reach the Aquatic Center directly the day of your fun-raiser night, please call 847-599-3780 if you are unsure on the opening status.** If we close due to weather within an hour of your arrival, we will be happy to reschedule your fun-raiser night. If your fun-raiser is underway and there is a pool closing, you will be given the option to reschedule.

Guests: All swimmers must shower before entering the pool. For children under eight years old, there must be one adult in the water within arm's reach for every 8 children in the water. For children nine years old and older, there must be one adult in the water within arm's reach for every 10 children in the water.

Hunt Club Park Shelter: Reserve the shelter, located just outside the Aquatic Center, to expand your fun-raiser night in a picnic setting. Additional fees apply.

Lifeguards: Our Ellis & Associates trained lifeguards are there for your safety, to enforce rules and respond to emergencies. Please follow their instructions along with the pool rules posted throughout the facility at all times.

Lifejackets: U.S. Coast Guard approved lifejackets are available for use, free of charge. For children using lifejackets, one adult to one child ratio must be met.

No Smoking: Gurnee Park District Ordinance prohibits use of any tobacco products on or within 25 feet of any Gurnee Park District playground, sports field, skate park, shelter or structure. Please use designated smoking areas.

Payment: MasterCard, VISA, Discover, cash and checks are accepted.

Personal Flotation Devices / Water Toys: Inflatable personal flotation devices, masks, fins, snorkels, squirt guns, sharp plastic toys, diving sticks, water wings, pool noodles and specialty equipment are prohibited.

General Rules & Guidelines

Refreshments: We offer a concession stand with numerous amenities. Carry in food is allowed and must be kept in the grassy picnic area or on the concession deck only. Glass is prohibited in the facility and all garbage must be placed in the trash receptacles.

Organization: A designated person from the organization must be 21 years of age or older and in attendance during the entire fun-raiser night. The organization will assume full responsibility for the fun-raiser and liability and is solely responsible for the actions of any member of the group both in and out of the water.

Water Slides: Guests must be at least 42 inches tall to use the flume, tube & speed Slides; 48 inches tall to use the Drop Slide. Yarn or string bracelets and anklets are allowed. All other jewelry is prohibited.

By signing below, I confirm that I have read, fully understand and will comply with all facility rules/guidelines. The Organization understands and agrees that it is the organization's sole responsibility to provide supervision for any and all activities contemplated by this agreement. The organization further understands and acknowledges that lifeguards are not responsible for providing supervision; rather, lifeguards are responsible for enforcing safety rules and responding to emergencies. Further, the organization and their guests are solely responsible for any aquatic activity contemplated by this agreement and that Gurnee Park District is not responsible for assessing the skills of any patron. Additionally, the organization understands and agrees that children 12 years of age and younger must be supervised at all times by a responsible person, 16 years of age or older and it is the organization's responsibility to enforce this requirement. Accordingly, the organization agrees that he/she shall communicate this requirement to all guests/patrons associated with and attending this fun-raiser night. The organization agrees to protect, indemnify, save and hold harmless Gurnee Park District including its officers, officials, employees, agents and volunteers (collectively "District") from and against any and all liabilities, obligations, claims, damages, causes of action, costs and expenses, (including reasonable attorney fees) which Gurnee Park District may become obligated by reason of any accident, injury, or drowning of any member of the organization's group (or caused by a member of the organization's group) arising indirectly or directly in connection with or under this agreement. Gurnee Park District is not responsible for lost, stolen or damaged personal items or personally rented equipment.
